Here is a complete list of everything you need to gather to prepare your tax return, whether you work with a W-2 or are self-employed.

## **Basic Documents (For All Taxpayers):**

### 1. Valid personal identification:

- o Passport or photo ID (driver's license).
- Social Security card or ITIN letters.

### 2. Dependent information:

- SSN or ITIN for each dependent.
- o Birth certificate or evidence of relationship.
- Form 8332 (if applicable).
- School record.
- Medical record for dependents under 6 years old.

### 3. Proof of address:

Utility bill, bank statement, or an updated official letter.

## If you are an employee with a W-2:

#### 4. W-2 forms:

- Collect W-2 forms from all employers you worked for during the year.
- Double-check that the information on your W-2 is correct.
- Unemployment form 1099-G, Form 1095 (health insurance Marketplace).
- o Form 1098.
- Personal property tax records.
- o Form 5498-SA showing HSA contributions.

# If you are retired:

Forms 1099-R, SSA-1099, RRB-1099.

# If you are self-employed:

# 5. Forms 1099-NEC, 1099-MISC, or 1099-K:

- Any forms received for services rendered, client payments, or payments from platforms.
- Bank statement to verify deposits.

# 6. Income and expense records:

- Sales or service invoices.
- Business expense receipts (fuel, advertising, software, vehicle taxes, sales tax, etc.).
- 7. **Business asset records**: (cost, date placed in service).
- 8. Home office information.
- 9. Receipts for estimated tax payments:
  - Proof of quarterly payments made to the IRS during 2024 (Form 1040-ES).

#### **Common Deductions and Credits:**

## 10. Proof of medical and insurance expenses:

 Bills for major medical expenses and proof of insurance payments.

### 11. Education-related expenses:

- Form 1098-T (if you paid tuition).
- Receipts for materials and books.

#### 12. Proof of charitable contributions:

Receipts for donations in cash or goods.

### **Important Extras:**

- For any interest earned (Form 1099-INT).
- For investments, Form 1099-DIV, 1099-B.
- If you made home improvements, like solar panels, check for applicable credits for 2025.
- Last year's tax return.
- Proof of investments, pensions, businesses, or rental properties abroad.
- If you received or sold digital assets (cryptocurrencies, Bitcoin, Ethereum, etc.).
